GENERAL SUMMARY

Operates fire department apparatus and responds to emergency calls involving fire, medical, hazardous materials incidents, motor vehicle accidents, water and other rescue situations. Performs station activities and fire prevention activities. Performs station duties such as apparatus maintenance, station upkeep and maintenance, and completing reports and related paperwork.

EXAMPLES OF DUTIES AND RESPONSIBILITIES

Responds to alarms, drives and operates emergency equipment and related apparatus and assists in the suppression of fires, including rescue, advancing lines, entry, ventilation and salvage work, extrication and emergency care of victims.

Raises and climbs ladders, uses bars, hooks, lines, and other equipment. Uses appropriate Personal Protection Equipment (PPE), including a self-contained breathing apparatus during hazardous incidents. Performs salvage operations such as laying salvage covers, sweeping and pumping water and removing debris.

Cleans, polishes and services equipment. Conducts tours of the stations for community groups.

Enthusiastically participates in all department training activities while on duty and is thoroughly familiar with all equipment. Continuously trains to be prepared to perform fire fighting and emergency response duties which may be performed under conditions requiring quick response and/or strenuous physical exertion. Takes initiative to train while on shift and is unwilling to be a wall flower in group trainings, understanding that as an active, paid personnel it is our duty to be proficient and highly skilled and trained for duty.

Participates in fire drills and attends classes in firefighting, medical response, and fire prevention.

Reports any damage to property, facilities, and apparatus during the shift that they are discovered.

ABILITIES

Is at the station at the start of each shift- ready, able, and dressed for the position. Remains at the station and available throughout the shift.

Follows all Department policies and SOGs, as well as Flathead County protocols and HIPPA requirements.

Fosters an environment of cooperation and mutual respect with the Marion FD volunteers, fellow employees, and all mutual aid personnel. Acts calmly under stress and pressure.

Take no compensation, tip, or gratuity for service rendered.

Accepts responsibility for his/her actions. Holds one's self accountable or answerable for his/her conduct. Is truthful and seen as credible in the workplace.

Is organized and able to follow a systematic approach of performing a task.

Is willing to share information freely with his/her supervisor and fellow employees, recognizing the fire service not only to be a professional service, but held to the highest standards of integrity, honor, and commitment.
